## **Explanation of Responses:**

1. Shares acquired pursuant to conversion of restricted stock units (RSUs) on a one-for-one basis. RSUs were issued pursuant to the issuer's management stock purchase plan under which directors may elect to receive RSUs in lieu of a pre-selected percentage of their annual director compensation. RSUs are issued on the basis of a 33% discount to the fair market value of the issuer's common stock on the date the director compensation would otherwise be paid. These RSUs convert into shares of common stock 3 years after the date of grant unless the director previously has selected a longer deferral period. With respect to he transaction reported herein, RSUs were issued on February 13,2002 and were converted into shares of Common Stock on February 13, 2005. Price reflected is equal to a 33% discount of the fair market price of the issuer's Common Stock on the date of the grant.
